## Kristen Bowden **Sharp to Share Her Story through Song** at Fall Luncheon

oin us for an exciting event with musical performer Kristen Bowden Sharp. Kristen sang her way into the hearts of adults and children alike in her lead role in Mary Poppins at Red Mountain Theatre this past summer. Some of Kristen's other roles include her national tour as Dorothy in The Wizard of Oz, Liesl in *The Sound of Music* and Mary Phagan in Parade. She has also appeared in such Birmingham favorites as The Sound of Music (Maria), Singing in the Rain (Kathy) and Les Miserables (Fantine).

Kristen has been praised by critics for her performances. In The Last Five Years, she was described as "coming through with flying colors" and "bringing to the role every bit of emotion it requires." A self-described hopeless romantic, Kristen thoroughly enjoyed her performance with artist David Friedman in the Red Mountain Theatre production of "Listen to My Heart: The Music of David Friedman." His music spoke to her heart. She described the role as "one of the most challenging things [she'd] done in theater" but believed that God had a plan for sending it her way.

God plays an important role in Kristen's life, both personally and professionally. She credits Him for the many blessings in her life-the opportunity to perform, her husband and her twins. She attends church at Trinity United Methodist where she sings in the choir. Her previous church was First Baptist Church Trussville, which still holds a place in her heart and where she helped with the creation and leadership of the new

contemporary worship service. Kristen was born and raised

in Trussville,

Alabama, developing her God-given talents at an early age as she danced and sang Sandi Patty songs in the privacy of her bedroom. Kristen credits her start in theater to her ballet teacher who announced a summer workshop and asked if anyone was interested. That initial interest led her to a large and public stage at the age of 16 when she began traveling the U.S. with Broadway shows. By the age of 17, she was living in New York City, leaving behind the quiet life of suburban Alabama for the bright lights of New York.

Kristen's life and priorities were changed after witnessing the tragic events on September 11, and she returned home to pursue a degree in marketing. She now leads a busy life as the mom of 8-year-old twinsbalancing performing, church, date nights with her husband and spending time with her children. Kristen still lives the exciting life of a performer. However, she is continuously learning to listen and let the Lord hold her heart, rather than pursuing the bright lights that are constantly calling her name. Kristen will regale everyone at the Fall Luncheon as she tells her story through song, ranging from show tunes and spirituals to her own compositions. She will be accompanied by the talented Kathryn Fouse, assistant dean of the Samford Department of Music.

Kaleen expressed that she feels truly blessed to have had this opportunity and is excited to share her experience and journey with us.

Dr. Vann received his undergraduate degree from Samford, then Howard College, and his doctorate from Florida State University. Excellence in Teaching. Dr. Vann retired from Samford after teaching 46 years. He has served as pastor of Rocky Ridge Baptist Church in Hoover, Alabama, since 1992. "A beloved Samford tradition, Dr. Vann's chalk talks are always among students' favorite convocations," says Sharon Smith.

Sara Williams Berry will be our guest as we gather on April 14. She is an author, blogger, teacher, missionary and mother. Sara is the author of two Bible studies titled Beyond Bethel and Stones from the River Jordan, as well as a novel named A Cord of Three Strands. She has also written a devotional book, three children's books and seven curriculum programs for children. During her 27-year career, she has taught elementary school, directed a tutorial program for inner city children and served as a program director for an inner city humanitarian service. Join us at our membership meetings this year to hear these special guests share their hearts and stories of how the Lord has worked in their lives, as He did in Esther's.



The sunset campus of Samford University **L** was the site of Legacy League's 7th Annual Scholarship Celebration on Thursday, May 7. Nearly 400 people, including members and their guests, sponsors, alumni, parents and friends of Samford, were in attendance for the musical evening of food, fellowship and entertainment. The event concluded last year's fundraising efforts, which raised more than \$100,000, and celebrated the creation of the Centennial Scholarship, which commemorates 100 years of teacher education at Samford. This new fund will provide assistance for students with significant financial need and challenging circumstances who are pursuing a career in education. To date, Legacy League has awarded nearly \$600,000 in life-changing scholarships.

Those with deluxe reservations began the evening with hors d'oeuvres on the Wright Center veranda. Guests mingled and enjoyed photo opportunities with Christian artist David Phelps. Everyone then convened for the al fresco buffet dinner held under a 5,200 square foot white tent adjacent to the Wright

Center. The candlelit setting was beautifully decorated with black linen tablecloths covered with burlap and topped with black lanterns and white hydrangeas. Magnolia leaves were abundant, and burlap ribbon tied both the napkins and large white draperies, forming columns around the tented arena.

The buffet featured beef and turkey carving stations as well as a smashed potato bar. Other delicious treats included a shrimp and grits station, baked crabmeat soufflé, buffalo chicken dip, Mediterranean garlic hummus, assorted vegetables, and abundant fresh fruits and cheeses. Tiered dessert trays offered a variety of sweet treats, tartlets and pastries.

After dinner, guests moved into the Wright Center where scholarship recipient Micah Green-Holloway thanked Legacy League for the privilege of attending Samford University and for helping to change his life. "I am literally a product of grace. I know God has a purpose for me being at Samford." Growing up in a neighborhood riddled with violence, crime and insecurity, Micah had no direction in his life. With guidance from his mom and a teacher,

Micah persevered, excelling as a student, a leader and an athlete. He is now a leader in campus ministry and serves as a Samford Ambassador.

Suzanne Hopkins, Scholarship Celebration chair, then introduced her former Baylor classmate, spirited tenor vocalist, songwriter and arranger David Phelps. A prominent member of the Gaither Vocal Band since 1997, David has received four Dove Awards and two Grammy Awards. Phelps told the enthusiastic crowd he loves to travel and sing, but he especially loves the connection with the audience where he "can share what the Lord has taught me. We are all on a journey . . . we are not done yet." His concert was the highlight of the evening, and the audience responded numerous times with cheers and standing ovations on numbers including "End of the Beginning," "Nessun Dorma," and "What a Wonderful World." The Legacy League helped that dream become a reality from 2008 to 2012. "Samford encouraged me to be one who deeply honors the Lord, is dedicated to a life of learning, and has an unwavering love for people."

She recalls two especially memorable events as a student. She spoke at the Legacy League's 2012 Scholarship Gala where best-selling author Andy Andrews encouraged her to pursue her dreams. The second significant occasion was when she received the Student Employee of the Year Award.

When asked what difference the Legacy League scholarship made for her, she responded, "My life would not be what it is today had it not been for the generosity of people like all of those who make up the

Legacy League and the loving kindness of Samford professors and staff who empowered and encouraged my future. Each year I prepared myself to await the news of what scholarship funds I would be able to rely on. And each year I was astounded at the unbelievable people I met who decided to be a part of adding priceless value to my story." Cassie now lives in Lake View and commutes to Vestavia Hills where she serves as the manager of a veterinary practice. She says she is surprised to have a career in the veterinary world, having majored in communication studies. However, she is certain her degree prepared her for this position. ### Share a Memory: How a Walk to the Dorm Began a Samford Legacy

When a tall, lanky ministerial student asked to walk me from Samford Hall to my dorm, I never envisioned the beginning of a Samford legacy.

Occupying the desk behind me in church public relations class, Jerome King often initiated conversation before class. I hadn't paid much attention to Jerome until he asked to walk me to Smith Hall, so I didn't even know his name. En route, he asked for a date. Standing in front of the student union building, I hesitated. "Um, let me check my calendar."

On the third floor of Smith, I described the young man to a sorority sister. She said, "That's Jerome King. If you go out with him, he'll never leave you alone." I accepted the date anyway, and he didn't leave me alone.

After a couple of dates, Jerome showed up at the public relations office, where I worked as a student correspondent, and surprised me with Valentine candy. News

Bureau Director Bill Nunnelley, now Samford's senior editor and director of public relations, commented, "This is looking serious." I wasn't so sure. Next, Jerome invited me for a weekend at his parents' home. Viewing our relationship as a friendship, I turned him down. The next week he inquired, "Have you prayed about this?" I confessed I hadn't. When I did pray, God helped me change my mind. That weekend in Muscle Shoals, Alabama, I began falling for the man I would marry in April 1968. What started on a walk from Samford Hall became a 41-year adventure of church ministry in three states-and a Samford legacy.

The legacy? All three of our children and their spouses are Samford grads, so, except for grandchildren ages 4–12, we have become a complete Samford family. All six have post-graduate degrees and include two

## **Raising Ebenezers** by Jeanna Westmoreland

am a preacher's kid. For many of you, the term "preacher's kid" conjures up stereotypical images of untamed children and teens, rebelling against their strict, religious upbringing. While I was certainly unruly at times and definitely engaged in a bit of rebellious behavior, my most enduring memory of stereotypical preacher's kid activity was learning to play the piano. As you know, a measure of success among the women in a traditional pastor's family is the ability to sing or play the piano or, even better, do both at the same time.

My piano lessons began in second grade with the rudimentary scales, basic music theory, simple songs and five-finger exercises. Once these were mastered and the basic piano curriculum completed, the goal became mastery of the music of the church. My mother envisioned my being able to open the hymnal to any random page and commence playing without missing a beat. Her vision translated into the parental edict that I could not quit piano lessons until I met that goal.

Being goal-oriented, even as a child, I set out to learn each and every hymn in the Baptist Hymnal (1956 edition), from hymn #1, "Holy, Holy, Holy," to hymn #542, "The Lord Bless You and Keep You." Yes, I also learned all the Amens that followed hymn #542, but being in Baptist churches in mostly rural areas, we didn't sing an Amen except on special occasions.

As my piano studies shifted from Beethoven to the Baptist Hymnal, I would ask a family member for a number between one and 542. I would turn to that hymn number, and if it were one I had not yet learned, I would start to work. As I practiced a new hymn, I would sing along, learning and singing each of the four parts, and, of course, singing all the verses. I had my favorites, usually because of the great alto or tenor part. I began and concluded my time at the piano each day with one of these favorites, belting out the alto or tenor part with my raspy voice at the limits of its range. It must have been a test of endurance for my family.

As I worked my way through the hymnal, I encountered tunes I loved with lyrics that sometimes puzzled me. Titles such as "There is a Balm in Gilead," "When I Can Read My Title Clear" and "There is a Fountain Filled with Blood" contained religious symbolism that was lost on me. I didn't have the life or loss experiences to understand or feel the meaning, but the combinations of notes themselves resonated in my soul.

One such favorite was "Come Thou Fount of Every Blessing." The second verse begins, "Here I raise my Ebenezer; hither by thy help I've come." As I learned that hymn, I was not familiar with the concept of an Ebenezer, and I had never encountered anyone who used the word "hither" in conversation. Yet, I sang those words, committed them to memory, and, years later, this hymn is still one of my favorites.

You are probably wondering why I am imposing this personal memoir upon you. The reason is found in the hymn from which I quoted above. Each of us in the Legacy League has experienced the "streams of mercy, never ceasing." In a variety of ways, individually and as an organization, we have experienced the abundant blessings of God. Likewise, we have raised an Ebenezer (in Hebrew, literally stone of help) to show to others that we have made it here (hither) with the help of God. We have our family stories or experiences that tell others of the faithfulness of God in our lives. We use these markers, our Ebenezers, to serve as reminders to others and ourselves that we have experienced challenges, but God was (is) with us.

In the Legacy League, each of our scholarships is an Ebenezer. Each one is a reminder that it is only through God's help that we are here. The story behind each scholarship, along with the funds awarded, testifies to its recipients, both figuratively and literally, God's faithfulness in meeting our needs.

Thank you for your testimony of God's faithfulness as we all seek to make a Samford University education possible for students with significant financial need.
